Vietnam War Veterans Day

Local Law No. ____ of 2022

(A Local Law Increasing Veterans Tax Exemptions)

Section 1: Legislative Intent

The Supervisor and Town Board have tremendous gratitude for the service of our Veterans. Recently, the State authorized local municipalities to increase the Tax Exemptions provided to Veterans. The Town honors its Veterans with events, memorials, and banners alongside roads and in Town Hall. It will now extend the Veterans Tax Exemptions to the maximum permitted under Section 458 and related sections of the Real Property Tax Law.

Section 2: Increase in Veterans Tax Exemptions and Text Amendments to Section 168-13 of the Town Code

The language in **bold** shall be added to Section 168-13 of the Town Code, and the language that is stricken shall be removed:

- A. Qualifying residential real property shall be exempt from taxation to the extent of 15% of the assessed value of such property; provided, however, that such exemption shall not exceed \$24,000 \$75,000 or the product of \$24,000 \$75,000 multiplied by the latest state equalization rate for the assessing unit, or in the case of a special assessing unit, the latest class ratio, whichever is less.
- B. In addition to the exemption provided by Subsection A of this section, where the veteran served in a combat theater or combat zone of operations, as documented by the award of a United States campaign ribbon or service medal, qualifying residential real property also shall be exempt from taxation to the extent of 10% of the assessed value of such property; provided, however, that such exemption shall not exceed \$16,000-\$50,000; or the product of \$16,000-\$50,000 multiplied by the latest state equalization rate for the assessing unit, or in the case of a special assessing unit, the class ratio, whichever is less.
- C. In addition to the exemptions provided by Subsections A and B of this section, where the veteran received a compensation rating from the United States veteran's administration or from the United States department of defense because of a service connected disability, qualifying residential real property shall be exempt from taxation to the extent of the product of the assessed value of such property multiplied by 50% of the veteran's disability rating; provided, however, that such exemption shall not exceed \$80,000 \$250,000 or the product of \$80,000 \$250,000 multiplied by the latest state equalization rate for the assessing unit, or in the case of a special assessing unit, the latest class ratio, whichever is less. For purposes of this subsection, where a person who served in the active military, naval or air service during a period of war died in service of a service connected disability, such person shall be deemed to have been assigned a compensation rating of 100%.

Dutchess County to Host Veterans Services Town Hall on Saturday, April 30th

Poughkeepsie... Dutchess County Executive Marc Molinaro with the Division of Veterans' Services will be hosting a live Veteran's Town Hall forum on Saturday, April 30th at 12:00 pm at the Elks Lodge at 29 Overocker Road in Poughkeepsie. The forum will include a panel of knowledgeable individuals including Dutchess County veterans program managers, members of the VA, and representatives from other local veterans' services who will discuss county and national resources and support available for veterans and their loved ones. Light refreshments will be served, and veterans and their families are encouraged to attend. Registration is not required.

County Executive Marc Molinaro said, "Connecting veterans to services and resources available to them on both a local and federal level is very important. Whether that's finding housing, employment services, or getting the mental health services they need to deal with post-traumatic stress or other issues our Division of Veterans Services and other veteran service programs can help. This forum is meant for veterans to have direct contact with veteran services as well as other veterans to make sure these heroes are getting the proper care and help, they deserve."

At the town hall, veterans will learn about resources available for them and their families, including new programs the VA provides and local services provided by Dutchess County veterans organizations. Representatives from Mental Health America (MHA) and Hudson River Housing will also be on hand to provide veterans information on programs such as Vet-Tap, H.E.R.O, Vet2Vet, and VetZero. There will also be a discussion about the VA's recently released Asset and Infrastructure Review (AIR) report and its recommendations for the Castle Point Medical Facility. Veterans can learn more about the public input process on this matter.

Following the panel presentations, there will be a question-and-answer period between service providers and attendees. Veterans and families are encouraged to ask questions and share their stories and experiences in a safe space surrounded by other veterans and those who work in veteran services. This period is meant to be informative and cathartic for all that need it.

Dutchess County Division of Veteran Services' Director Adam Roche said, "It is our mission to give these honorable men and women the time and attention they deserve. This event will provide veterans with the most up-to-date resources and services to ensure their wellbeing in all facets of life."
