# **Internet Savings**

Member Jeff Dunay brought to our attention a government program that will save you \$30.00 per month off your internet bill. Here are the ways your household can qualify for the Affordable Connectivity Program (ACP):

- Based on your **household** income
- If you or your child or dependent participate in certain government assistance programs such as SNAP, Medicaid, WIC, or <u>other programs</u> (Veterans Pension and Survivors Benefit)

Basically, if you have a military pension or receive disability payments from the VA, you qualify. Applying is easy. I did it the morning after our January meeting. Start at <u>getinternet.gov</u> Follow instructions and you can get immediate approval. Then you take that information to your service supplier (Optimum or Verizon) and apply with them. Optimum told me it would take two billing cycles for the discount to appear on my bill.

The Affordable Connectivity Program will stop accepting new applications and enrollments on February 7, 2024. Consumers must be approved and enrolled with a service provider by 11:59 p.m. ET on February 7th to receive the ACP benefit.

## Dues Increase for 2025.

The American Legion's last national per-capita dues will increase from \$18.50 to \$23.50 for the 2025 membership year. The \$5 increase will go into effect July 1, 2024.

American Legion posts are encouraged to complete a post data report in MyLegion.org as quickly as possible to increase your post dues rate, if needed. An early submission will ensure enough time for processing.

And posts should check with their respective department about their per capita dues as well.

The due increase comes at a time when the need for American Legion advocacy, expertise, influence, services and programs are needed in every corner of our nation and because of the current membership standings and economy. This is a time to continue supporting The American Legion's ability to serve veterans, members of the U.S. armed forces and young people. A national \$5 per-capita dues increase can prevent National Headquarters from having to cut programs and services. The American Legion's ability to succeed over the next decade depends on positive cash flow and the ability to invest in the future.

Therefore Post 1758's dues will rise to \$50.00 per year starting in 2025. You will see the increase on your renewal notices starting this July.
