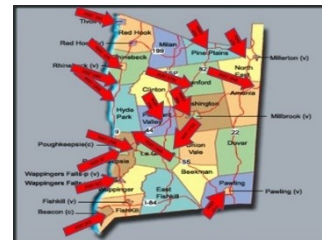

July 31st:	Remittance of Post 9th District dues to County Treasurer. \$4.00 per Post.
August 8	Make contact with local schools, to inform them about the Oratorical an Boys State, and what are the commit dates
September 1st:	Submittal of bids for the Department Commander's Visitation Dinner.
October 25th:	Oratorical Contest. Posts should have at least one contestant chosen by this date to compete in the County Contest. Notify County Chairman.
November 1st:	Submittal of reservations for the Department Commander's Visitation Brunch and Dinner.
